### SPEED CALCULATIONS FROM PEDESTRIAN THROW DISTANCE.

THEY WILL ALSO LEARN WHAT ASSUMPTIONS (PRESET VALUES) THE VARIOUS AUTHORS HAVE MADE WITHIN THEIR EQUATIONS, AND HOW THOSE ASSUMPTIONS MAY AFFECT THE RESULTS OF THE EQUATIONS AND ITS APPLICABLY TO THEIR INVESTIGATION.
